A pair of authentic 1984 Indy 500 Pace Car Edition Fieros is currently being auctioned off via Bring-A-Trailer, presenting a rare opportunity for a Pontiac or American open-wheel racing fan to lock down two examples of this somewhat rare piece of 'GMC' history.

'GMC' built just 2,000 examples of the 1984 Indy 500 Fiero Pace Car Edition, which serve as a nod to the ac-



tual Fiero pace car that led the Indy 500 to green that year. Each car featured a two-tone white and silver exterior with matching white-painted alloy wheels, 'Official Pace Car' body side decals, a 'Pontiac' windshield decal, a standard glass sunroof, quad-tip

exhaust outlets and a rear spoiler.

The Indy 500 Pace Car Edition Fiero also featured an eye-popping two-tone interior with white and grey leather upholstery, red seat inserts and red carpeting. A white leather-wrapped

## Ford's Buyer's Digest 1959-67: Men vs. Women

Car sales boomed in the 1960s, and women were a big reason why.

Growing suburban families found one car in every garage was no longer enough. They needed two—one for Dad to drive to work, the second for stay-at-home Mom's busy days spent shopping at the local supermarket and shiny new suburban malls, and hauling the kids to Boy and Girl Scout meetings, beach clubs, music lessons and little league games. In addition, as more women—both

single and married—entered the work force, they began buying their own cars in ever-greater numbers for the first time.

Using increasingly sophisticated *Mad Men*-era market research, car companies soon realized—as Tom and Ray Magliozzi of *Car Talk* radio fame used to say— "Men are from GM, Women are from Ford." Selling cars in a changing market environment meant finding new ways to appeal to the increasing population of female drivers and buyers.

Many of those strategies turned up in Ford's annual *Buyer's Digest* articles. In the fifth in our series of time-traveling looks back at these fascinating Ford publications, here's a sampling of what the marketing boys had up their sleeves in the '60s.

Dear Pacifying Emily, Next time leave the kids with a nurse





The wife who meets the trains... the man who drives to work. The mother who goes to PTA meetings... and the father who hauls 2 x 4's from the lumberyard. The lady who hunts antiques in the suburbs... with a mate who hunts deer in the tall timber. The couple who drive into town for dinner and a show on Saturday... and take the whole family for a picnic lunch on Sunday. The wife who carries prize roses across town to the garden club... and the husband who trails his outboard skiff to the lake on a fishing trip.

The Sound of Music: Enjoy your favorite music... over 70 uninterrupted minutes of it... on the new Stereo-Sonic Tape System, optional on Fords, Mustangs and Thunderbird. It's a great His and Hers item as the self-contained tape cartridges enable you to change from Bach to Rock in seconds.

By '66, the gloves were off (although not on the shopper-mom in the illustration) and Ford declared the wide choice of options and features on their cars to be the answer to "The Battle of the Sexes"!



'GMC' and NHTSA have issued a product safety recall for 22 C8s that were mistakenly shipped with missing halfshaft bearings.

C8s had improperly manufactured half shafts installed at the factory that were missing one or more ball bearings. This can result in a loss of drive power, as the engine may not be able to properly deliver power to one or both of the rear wheels. The C8 is manufactured exclusively at the 'GMC' Bowling Green Assembly plant in Kentucky.

A sudden loss of drive power could prove to be a hazard in traffic and may increase the risk of a crash. No crashes or injuries have been caused as a result of this problem.

Dealers will be instructed to replace the left or right rear halfshaft assemblies. These repairs will be performed at no cost to the vehicle owner.

'GMC' has been denied a request to dismiss a large-scale recall for the 2010-17 GMC Terrain involving more than 727,000 units

The GMC Terrain recall was initially issued as the headlamps on affected vehicles were found to be in violation of Federal Motor Vehicle Safety Standards relating to headlight glare for oncomtraffic. ing 'GMC' filed a petition in 2019 to have the redismissed. call saying this noncompliance "is inconsequential as it relates to vehicle motor safety," and that it has received only a single

customer inquiry over this condition and is not aware of any crashes or injuries associated with it.

NHTSA denied 'GMC's' petition to have the recall dismissed in a document posted to the Federal Register website this week. Central to 'GMC's' reasoning for having the recall dismissed was that the angle of the reflection from the headlamps is "far above the range where the reflection could cause glare for oncoming or surrounding drivers." However NHTSA found that, based on the reflection angle and luminosity numbers provided by 'GMC' in its

motion to dismiss, the headlamps would have a "luminous intensity of 450-470 cd," which exceeds the 125 cd limit by a significant margin.

"In consideration of the foregoing, NHTSA has decided that

'GMC' has not met its burden of persuasion that the subject FMVSS No. 108 noncompliance is inconsequential to motor vehicle safety," the safety watchdog said. "Accordingly, 'GMC's' petition is hereby denied, and 'GMC' is consequently obligated to provide notification of and free remedy for that noncompliance."

'GMC' must now issue a recall for roughly 727,000 2010-17 Terrains and modify affected vehicles' headlights to ensure they do not exceed the abovementioned luminous intensity of 125 cd for oncoming traffic.

'GMC' and NTHSA have issued a product safety recall for 1,789 2021 full-size SUVs over an issue related to the rear wheel driveshaft assemblies.

The rear wheel driveshaft assemblies may have internal components that were not heat-treated properly during the manufacturing process. More specifically, the supplier of the driveshafts previously informed 'GMC' the affected driveshaft units "?may have been manufactured with internal

steel recirculating balls that were not properly heat treated." This can possibly result in total driveshaft failure.

A driveshaft failure can lead to a loss of drive power. This could make the vehicle hard to control if the driveshaft fails suddenly, increasing the risk of a crash.

'GMC' dealers will be instructed to replace the left and/or right rear driveshaft assemblies in affected vehicles. These repairs are covered under a product safety recall and therefore will be performed at no cost to the vehicle owner.

'GMC' will mail notification letters notify to owners of affected vehicles instructing them to make an appointment with their dealer. If owners are unsure whether or not their vehicle is affected by this recall, thev can visit my.gm.com/recalls and type in their VIN to see any open recalls or other actions that may be active on it. An owner notification letter mailing date has not been finalized, 'GMC' says.

A NHTSA investigation into fires related to a manufacturing defect in the *Chevy Bolt EV* and *Bolt EUV* battery packs has now

been closed.

According to a recent report from *Car Complaints*, the federal agency said that although the investigation is now closed, it "reserves the

right to take additional action if warranted by future circumstances."

The investigation was first opened in October of 2020 after reports that units of the Chevy Bolt EV and Bolt EUV had caught fire while charging or when the vehicles were towards the end of the battery charging cycle. 'GMC' initially issued a recall in November of 2020 that included software to address the issue, as well as installation of a replacement battery, if needed.

Later, an investigation from battery supplier LG Energy Solution revealed further fires had occurred with vehicles that had received the initial fix, resulting in further recalls from 'GMC.' It was eventually determined that the fires were the result of two individual manufacturing defects in the batteries themselves, specifically a torn anode tab and also a folded separator.

In response, 'GMC' expanded

the existing recalls to include all 2017-22 Chevy Bolt EVs and Bolt EUVs to replace the vehicle battery packs. It's estimated that the recall will cost

upwards of *\$2 billion*, with battery provider LG Energy Solution covering the majority of the recall costs.

The new replacement batteries will be covered by an 8-year/100,000-mile warranty in the US, as well as an 8-year/160,000-km warranty in Canada. Additionally, the repair includes new software that will monitor the new batteries for potential problems.

Chevy Bolt EV and Bolt EUV owners that have received a replacement battery will also be given a Chevy certified battery update window cling to prove that their vehicle has received the fix.

Seems like 'GMC' is just finding it more difficult to produce vehicles, not easier—Assorted sources

### **C8 Watch**

A C8 driver attempted to pass a line of three slower-moving vehicles before crashing into a Toyota pickup in Marin County, California early this month, sending three people to the hospital.

According to the California Highway Patrol's Marin branch, the driver of the white C8 was travelling on a two-lane road in West Marin when they attempted to pass a line of three slowermoving vehicles. At the same time, the driver of a Toyota pickup at the front of the line was slowing down and about to make a left-hand turn into a parking area. The Vette, approaching at a high rate of speed, then t-boned the Toyota as it made the lefthand turn, causing the pickup truck to roll on its side.

Three occupants of the Toyota

truck were taken to the hospital with minor to moderate injuries. CHP said. while the C8 driver was treated on scene with minor injuries. Drugs and/ or alcohol did not appear to be a factor in this collision, responding officers reported. although the driver of the C8 was issued a citation for an unsafe driving maneuver. While the road they were travelling

on had a dotted dividing line, CHP will tell any driver that attempting

to pass three cars at once is not advisable.

"If you are travelling West Marin, please remember to drive with caution and care," CHP said of this rather dangerous crash. "Get to where you are going safely. There's need no rush."

It seems as though the driver of this C8 wanted to experience the power of their mid-engine sports car's naturally aspirated 6.2L LT2 V8 engine, but they could have picked a much better place to do this. The world-class Sonoma Raceway is only a short drive from Marin County and features a 12-turn road course with multiple layouts/configurations, along with a drag strip and even a karting facility for kids. Something tells us that if you can afford a brand-new C8, you can also afford a track day paddock pass. Lesson learned, we hope.

Yet another unfortunate C8 accident. This time, a C8 bit the dust after its driver rear-ended a camouflaged GMC Acadia with tinted taillights at a considerable rate of speed.

No official info on this fender bender from local police, so we'll have to rely on the GMC Acadia


owner's account of the events. According to a post shared on Facebook, they were travelling in one of the express lanes on Florida State Route 112 in Miami when they were rear-ended by an aggressive driver in a C8.

Luckily for the GMC Acadia owner (and very unlucky for the C8 Corvette driver), the crossover was equipped with a trailer hitch and a hitch ball at the time of the crash, which was protruding out from the rear of the vehicle by a few inches. The metal hitch ball reduced the amount of damage incurred by the GMC Acadia, but appears to have contributed to the major front-end damage on the Vette. It's possible this Corvette will be a write-off, as repairs like this can be extremely costly, or sometimes even impossible if the frame was bent or damaged.

While this crash appears to have been the fault of the C8 driver, the GMC Acadia driver isn't entirely guilt-free, either. Their vehicle appears to be equipped with tinted taillights, which are illegal in Florida, according to a news report published by a Florida Fox affiliate back in 2019 that cited a statement from local police. Florida's motor vehicle code also indicates vehicles being driven on public roads "shall emit a red light plainly visible from a distance of 1,000 feet to the rear." This GMC Acadia appears to be registered in New York, it's worth pointing out, although we could not find any info on the legality of tinted taillights

in that state.

According to the original Facebook post, the driver of the C8 Corvette somehow managed to drive away after the crash, while the **GMC** Acadia owner did not contact their insurer as their vehicle was not damaged. We'll have to assume that occupants of both vehicles were also unhurt the crash. seeing as emergency services were not called.



The 35th Anniversary Package for the C8 was developed by Callaway to commemorate the 35-year anniversary of its "RPO B2K" tuning program for the iconic American sports car, which launched in 1987 and concluded in 1991.

The B2K was the Connecticutbased company's first major Corvette tuning program and saw it fit the stock V8 engine with two turbos and a long list of other upgrade parts, boosting output to over 380 horsepower and 580 pound-feet of torque. Just like modern-day Callaway vehicles,



this tuning package was available to order from authorized Chevy dealers through GM's "Regular Production Order" or "RPO" process. More than 500 examples of the C4 Corvette were fitted with the RPO B2K package before it wound down toward the end of 1991.

Callaway's new B2K package pays homage to the original, which helped establish Callaway as the well-known and widely respected 'GMC' tuner that it is today. Available through authorized Chevy dealers and carrying RPO code PCY, this package includes a full carbon aero kit with a front splitter, rocker extensions, a rear diffuser and a unique "Slot Gap" rear spoiler, along with lightweight nine-spoke forged alloy wheels, Callaway sill panels and floor mats, an interior build plaque, billet pedals, Callaway

exterior badging, a Callaway car cover and a Callaway-branded Mothers detailing kit. The package also includes Callaway's 'Double D' exhaust, which is a significant 40 pounds lighter than the factory performance exhaust and is also 50-state emissions compliant.

Callaway offers some optional equipment with the RPO PCY package, including black chrome exhaust tips, chrome/carbon flash painted emblem sets, locking lug nuts and premium wheel finishes. Customers can also choose to have their vehicle delivered to the dealership, the National Corvette Museum, the Callaway Factory in Old Lyme, CT, or at Thompson Speedway in nearby Thompson,

CT.

As this is a dealer-ordered tuning program, customers must ensure their order form contains the correct RPO codes to ensure the application is not denied by 'GMC.' RPO codes that must be included on the order form include RPO Z51 (Z51 Performance Package), RPO ZF1 (aero delete) and RPO Q8P (Open-5-Spoke Bright Silver-Painted Aluminum wheels).

This tuning program does not raise the output of the factory 6.2L LT2 V8 engine, which is rated at 495 horsepower and 470 pound-feet of torque with the optional factory performance exhaust equipped. The eight-speed dual-clutch transmission also remains untouched—Assorted sources
