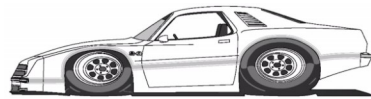

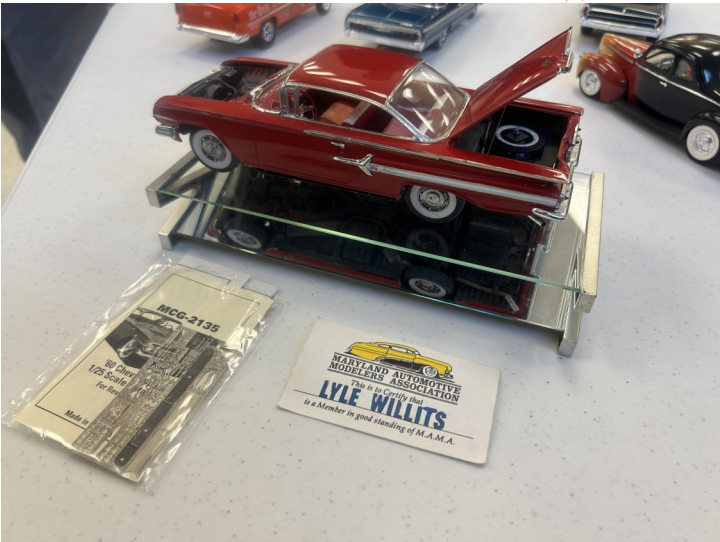

C8 News

The *first production '25 C8 ZR1 is now spoken for*, auctioned off for a cool **\$3.7 million** at **Barrett-Jackson Scottsdale 2025**. The full hammer price of VIN 001 will be donated to charity, benefitting the Red Cross with all auction fees waived.

Unsurprisingly, **Rick Hendrick**—Corvette aficionado, championship NASCAR Cup series team owner, and the man at the helm of Hendrick Automotive Group—will be the one to take that Vette home.

Hendrick has an expensive Corvette VIN 001 habit. He scored the first production '24

Corvette E-Ray for **\$1.1 million**, along with the first '23 Corvette Z06 for **\$3.6 million**, the first retail '20 Corvette convertible for **\$400,000**, and the first C8 coupe **\$3 million**. He also placed the winning bid on the first production '19 C7 ZR1 'way back in '18, so his latest acquisition will fit right in with

his collection.

'GMC' pulled the sheets off the latest ZR1 in July, unleashing the fastest, most powerful production Corvette in the nameplate's history. The lean, mean, supercar-killing machine harnesses the twin-turbocharged 5.5L V8 LT7 gas engine, tuned to deliver a blistering **1,064 hp at 7,000 RPM**. All those ponies can gallop from 0 to 60 mph in just

2.3 seconds, and it boasts a top speed of over 230 mph.

Of course, when the '25 C8 ZR1 starts rolling off the assembly line in droves, it won't cost nearly as much as Hendrick paid for his. As previously reported by **GM Authority** (GMA), pricing for the '25 ZR1 1LZ coupe will start at **\$174,995**, including destination freight charges (DFC). The most expensive model of the bunch is the Corvette ZR1 3LZ convertible, starting at **\$195,995**. That's a pretty penny for sure, but nowhere near the \$3.7 mil hammer price raked in by VIN 001—*Assorted sources* 🐾

'GMC' has issued product recalls for the following vehicles:

- A total of **5 2024 Chevy Silverado EVs** and **2024-25 GMC Sierra EVs** with improperly secured rear center seat belts.

The bolt that secures the rear center seat belt assembly to the seat structure in affected vehicles may not have been properly tightened.

An improperly secured seat belt poses a safety risk to passengers occupying the rear center seat of the affected trucks.

'GMC' service techs at EV-certified dealers are instructed to tighten the bolt that attaches the center seat belt assembly to the rear seat to the proper torque specifications.

'GMC' is currently facing a **major quality control issue** related to the naturally aspirated 6.2L V8 L87 gas engine, found in the **2021-24 Cadillac Escalades/Escaade ESVs, 2019-24 Chevy Silverado 1500s, 2021-24 Chevy Tahoes, 2021-24 Chevy Suburbans, 2019-24 GMC Sierra 1500s, and 2021-24 GMC Yukons/Yukon XLs**, among others, including a **Cadillac Escalade failing on the dealr's lot with only FOUR miles on it!** Reports

of engine failures have surged, leaving many owners stranded with disabled vehicles and no clear timeline for repairs. The problem has become so severe that National Highway Traffic Safety Administration (NHTSA) has launched an investigation after receiving over a thousand complaints from affected owners, with **877,710 vehicles now under the microscope.**

The failures are rooted primarily in bearing failures and collapsed lifters, both of which can render the engine completely inoperable. According to a report from **The Drive**, while many of the affected vehicles are still under warranty, 'GMC's inability to supply enough replacement engines has left owners without much recourse. Not only that, but dealers have struggled to meet repair demands as 'GMC' attempts to balance new vehicle production with replacement parts, creating an ex-

tended repair backlog.

As highlighted by **The Drive**, the issue is particularly impactful for business owners and fleet operators, who rely heavily on their vehicles for daily operations. As mileage quickly accumulates, often exceeding warranty limits, affected owners are sometimes forced to spend upwards of **\$10,000 for a new engine**, with no guarantee of when repairs will

EV Blues

A *Cadillac Lyriq* owner is facing a frustrating experience and a major expense over a simple replacement part for his new all-electric crossover.

According to a report from [NJ.com](https://www.nj.com), Levan Azrumelashvili has waited **NINE months** for a **new bumper**, leading to a major impact on his limousine business. Azrumelashvili purchased his new *Cadillac Lyriq* as a company vehicle in December of 2023, shelling out **\$86,000**. However, the vehicle has been out of service since a minor accident in April of 2024, leaving him unable to operate his business while incurring significant financial losses.

According to Azrumelashvili, the new crossover costs him **\$1,100 in monthly insurance** and **\$1,437 in monthly car loan payments**, all while his *Lyriq* sits unusable as it awaits repair. Despite initial reassurances from Cadillac that the replacement part would arrive soon, Azrumelashvili has faced months of delays, inconsistent updates, and a lack of clarity on a possible solution. His efforts to escalate the issue included reaching out directly to **'GMC' CEO Mary Barra** and other company executives, as well as contacting media.

In response, 'GMC' offered a

small **"good will adjustment"** of **\$3,593.47** last October, representing less than half of Azrumelashvili's monthly payments. Alternatively, a 'GMC' representative said that the crossover could be eligible for a vehicle buyback. However, the buyback proposal was later rescinded without explanation, deepening Azrumelashvili's frustration. Adding to the confusion, 'GMC' later claimed the part had arrived, only for the body shop to report further delays amid rumors of a recall.

'GMC' has stated that it will work directly with Azrumelashvili to resolve the matter, but after nine months, no solution has materialized.

"I'm at a sheer loss situation and my car has lost a year of its value. I was unable to work and provide for my family this year and we faced many hardships," Azrumelashvili said, per [NJ.com](https://www.nj.com). **"Ultimately, I'm very disappointed I chose Cadillac to only face what I did. I feel as if I was taken advantage of and thrown to the curb."**

YouTuber Steve Lehto, a Michigan attorney, also covered the story in a recent video online.

No solution as of this article.

Meanwhile, a Memo-



randum of Understanding signed by **'GMC'** and **Hyundai Motor Group** in September is taking shape, and we're getting glimpses of what the collaboration between two of the world's largest automakers will look like. In recent statements on an analyst call, a Hyundai executive revealed that the Korean automaker is considering **selling electric commercial vehicles in North America rebranded as 'GMC' models**.

"We are considering rebranding our commercial EVs and supplying 'GMC'... The deal will pave the way for our entry into the North American commercial vehicle market," Hyundai Chief Financial Officer Lee Seung Jo said on the call, according to Reuters.

It's unclear at this time which commercial vehicles Hyundai and 'GMC' are considering marketing in North America. One possible candidate is the Hyundai ST1, a commercial EV platform with a customizable ladder frame optimized for cargo loading. Its most common application will likely be as a small cube truck. Hyundai also makes the Elec City electric city bus, which could be marketed as a 'GMC' model for North

be completed.

One livery service owner states that as soon as her **2023 Cadillac Escalade** began exhibiting signs of lifter failure, she acted immediately to quickly source a new engine. Unfortunately, her efforts were in vain, as although she sought to address the issue weeks before the Escalade's L87 was rendered inoperable, a replacement engine simply could not be found. Now, her vehicle has now been out of commission for weeks, costing her an **estimated \$30,000 in lost revenue**, all with no clear resolution from 'GMC.'

'GMC' dealerships are also facing the impact, with some resorting to hoarding replacement engines for high-priority customers, leaving others to fend for themselves. Social media posts

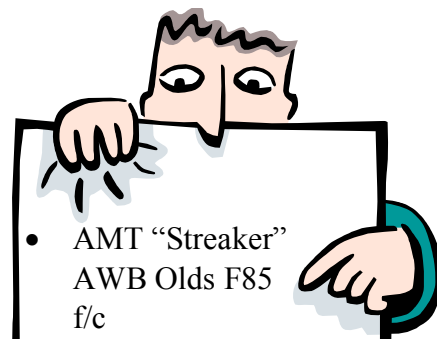
indicate that dealers are now attempting in-house rebuilds as well, despite 'GM's' recommendation to avoid such practices.

For some customers, an entirely new vehicle is the only solution to keep their businesses operational, adding yet another financial burden to the mix.

Finally, a 'special coverage program' announced in a recent bulletin by 'GMC' related to a problem with the evaporative emissions purge pump will result in "special coverage" extending the time during which a free fix is available for an **unknown number** of vehicles, including **2022-23 Cadillac CT4s, CT5s, XT4s, XT5s, and XT6s, 2022 Chevy Silverado 1500s, 2022-23 Chevy Blazer crossovers, and 2022 Chevy Traxes**. This period is extended to **15 years or 150,000 miles, whichever comes first**.

Looks like 'GMC' has their work cut out for themselves in the short-term—*Assorted sources* 🍷

American cities.

“We expect more business uncertainties this year than ever before due to potential policy changes not just in [South Korea] but also in the US, while there will be tougher emission rules in Europe,” Lee added, referring to a potential Trump administration tariffs and recent political unrest in Seoul.

On the subject of tariffs, Hyundai plans to increase localized manufacturing in the US to minimize potential tariff costs. It also plans to build hybrid models at its new Metaplant America in Georgia, which opened in 2024. There, it’s currently producing the Hyundai Ioniq 5 and soon the Ioniq 9.

In other ‘GMC’/Hyundai collaboration news, it was reported in November that the automakers were considering

jointly developing a *pickup truck* for the Latin American market. The report from Pulse at the time stated that one truck would be marketed under both ‘GMC’ and Hyundai brands to broaden reach in more segments in more global markets while keeping development costs low—*Assorted sources* 🚗

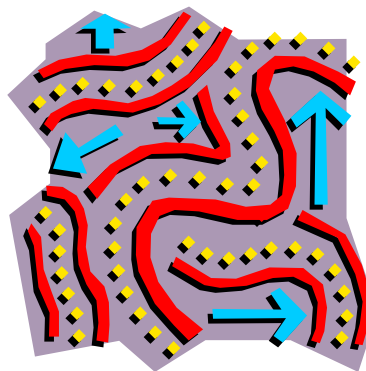
