B-J Auction Insanity

As we continue to mourn the loss of the sixth-gen Camaro, which was discontinued in 2024 with no direct replacement, there are still some out there in new or likenew condition that are up for grabs. One very special example appeared at the Barrett-Jackson 2025 Palm Beach auction late last month, the very first 2024 Camaro ZL1 Collector Edition (CE) ever produced.

The panther badge on the bottom of the steering

wheel of this ZL1 indicates that it's number 001/350, confirming it was the first-ever Camaro ZL1 CE. This car is already rare and desirable, and its first-ever status and 85-mile odometer reading multiply its collectability.

Not only is this likely one of the last ICE-based Camaros ever made, but production was relatively limited, with only 1,335 CE units produced. Of those 1,335 units, just 350 are the range-topping

ZL1 trim (274 in the coupes and 76 convertibles).

The content of the CE package varies between the different trim levels. ZL1 models receive a black metallic center stripe, badging, Black Panther matte paint, a Mosaic Black front splitter and grille, a carbon fiber spoiler, and more. Like all sixth-gen ZL1 models, this one cradles the mighty supercharged 6.2L V8 gas engine.

It's hard to predict a sales price for such a

Rodding History?! It's always fun to see obscure concept cars go up for auction, and we have quite an oddity to show you today. The unique 1998 Cadillac EldoRODo is up for auction in Wisconsin on Bring a Trailer. It is still in excellent show car condition with 8,500 miles on the clock. Built by Huntington Beach-based California Street Rods in collaboration with GM. the Cadillac EldoRODo was originally built as a tribute to Southern California car culture and takes inspiration as a sort of futuristic low rider. It was shown at various car shows, including the LA Auto Show, and it was featured in a few car magazines that were in vogue in the 1990s. While it retains the general shape of the Eldorado's final generation, this concept's body was chopped to accommodate a four-inch drop courtesy of its air suspension system. It also has a steeper windshield rake to make a lower roof. The front end was fabricated to give it thinner headlights and a slimmer grille in line with the car's overall lower profile. It's

finished in Ignite Orange, a much more daring color than the aver-12th-gen age Eldorado. The Cadillac Eldorado hasn't had skirted wheels rear from the facsince tory 1974. but this Cadillac concept has wheel

skirts as a nod to the car's heritage. Speaking of the wheels, it rides on 18-inch wheels wearing chrome plates bearing the Cadillac crest. Around back, you'll find a smooth rear end with thin, vertical tail lamps and exhaust tips to match. The Neutral Shale interior is more normal than you might expect. It has the plush seats typical of this era of Cadillac, heated front seats, and Bose audio. The only notable interior modification is some carbon fiber trim. It's also mostly stock under the hood, with a 4.6L V8 Northstar making 300 horsepower and 295 pound-feet of torque. Power is routed to the



front wheels via a 4-speed automatic transmission. The high bid for the Cadillac EldorRODo is at \$15,250 as of this writing, and the auction ends on Wednesday, April 16th. It has a junk title and no muffler, so there might be a challenge in making this street legal, but it makes a fine addition to any collection of unique GM vehicles—(Thanks to GM Authority, Autoweek, and other Internet sources for this insanity! Ya just can't make some of it up!! Thanks also to those of you in the Peanut Gallery who have helped entertain by sending stuff—I 'preciate it!)— Assorted sources



C8 Watch

The Florida Highway Patrol (FHP) is showing off its latest acquisition—a 2023 C8 Stingray. It was seized "from a drug dealer" and been repurposed for use as a patrol vehicle, as well as for use in community outreach, recruitment, and public safety awareness. In addition to posting a series of photos highlighting the new patrolspec C8, FHP also posted a video showing it on patrol.

Looking over photos of the new FHP ride, there is a custom two-tone paint scheme, with glossy black bodywork underneath a creamy tan roof and rear deck, tying back to the standard FHP color scheme. Prominent "STATE TROOPER" markings are applied to the rear quarters, doors, and bumper, while the Florida Highway Patrol badge is displayed on both doors and the rear bumper. The official plate reads "3870", a unique FHP identifier.

This C8 is also equipped with blue LED flashers in the front fascia, lower grille, side markers, and rear bumper, and a low-profile light bar mounted across the inside top of the windshield. Inside, this upgraded C8 equips a standard MDT, or Mobile Data Terminal, allowing officers to access

police databases, issue citaand retions. dispatch ceive updates. There's also a portable radio and controls for the emergency lighting and siren system.

Assuming this C8 is equipped with the optional Z51 package, the naturally aspirated 6.2L V8 is equipped with a factory performance exhaust system, upping output to 495 hp. The package also includes an electronic limited-slip diff, performance-tuned suspension, and upgraded cooling systems.

In a video, FHP states that the Vette was handed over to the police department through an asset forfeiture following a joint task force operation with the DEA. The vehicle was originally owned by a criminal suspect, and after being seized during the investigation, it was repurposed for law enforcement use. FHP states that no taxpayer money was used to obtain the car.

On the opposite end of the spectrum, it's not often we see a *Corvette food truck*, but that's exactly what the "*Vettro*" is, and it's on display at the New York

International Auto Show. It's going for a world record that nobody was keeping track of previously: the world's fastest food truck.

The basis of



the Vettro is a 2021 C8 Stingray Z51. That's right: a C8-based food truck. The body is sourced from a 1952 International Metro van. Vette plus Metro equals Vettro. It was built by Luc's Fajita Hut, which serves New Jersey and New York.

One of the most amazing things about the Vettro is that it appears to have a largely unmodified C8 interior. The seats, steering wheel, dash, infotainment screen, and center stack all look factory.

It's a little unclear how capable the Vettro is at actually preparing food. Unlike a more traditional food truck, it doesn't have a full-blown kitchen inside. It's mid-mounted powertrain, comprising a 6.2L V8 mated to an 8-speed dual-clutch transmission, is in the way.

Instead, it has panels on the sides of the body to reveal serving areas, and Luc's Fajita Hut has demonstrated that there's enough room for a Snap-On toolbox that was converted into a beer tap. The actual fajita cooking would need to occur in a different truck, but the Vettro can store and serve said fajitas.

This C8 food truck will go for

'GMC' has issued product recalls for the following vehicles:

A total of **597,630 2021-24** Chevy Tahoe/Suburban, GMC Yukon/Yukon XL, and Cadillac Escalade/Escalade ESV full-size SUVs. The recall refers to a problem in which the 6.2L V8 has manufacturing defects that can lead to loss of propulsion, engine damage, and engine failure. 'GMC's decision to issue a recall follows a series of lawsuits, investigations, and engine replacements regarding consistent problems with this engine.

'GMC' notes that the connecting rod and/or crankshaft components in the aforementioned vehicles may have unspecified manufacturing defects.

Manufacturing defects in the connecting rods or the crank-shaft can ultimately lead to *engine failure*, increasing the risks of an accident.

Full-size SUVs affected by the recall will be inspected for manufacturing defects. Those that pass inspection will receive an engine oil and filter change, this time using high-viscosity 0W-40 Mobil 1 Supercar oil. The owner's manual for these models calls for

necting rods, crankshaft, engine oil, filter, oil fill cap.

'GMC' will notify owners of affected SUVs. Additionally, 'GMC' has placed a stop sale on SUVs currently in dealership inventory, meaning they cannot be sold, delivered, used in demonstrations, or traded to other dealerships until they've passed inspection and gotten the appropriate oil change. The SUVs that do not pass inspection cannot be sold or delivered to customers.

An unknown number of 2023 -24 Chevy Low Cab Forward (LCF) 3500, 4500, and 5500 trucks equipped the 6.6L V8 due to an issue related to the

ignition coil pack fuses.

The trucks may have a condition where incorrectly sized wire seal was selected for the two externally mounted engine ignition coil pack fuse holders. This mishap could allow for potential water intrusion into the fuse holders and lead to eventual corrosion or failure of the fuses.

If the ignition coil packs were to fail, there are a number of events that could occur, including:


- 1) The Check Engine Malfunction Indicator Light may illuminate and the engine may misfire and produce decreased power output.
- 2) The truck may derate and limit maximum vehicle speed to 5 mph. However, power steering and power brake assist would still function normally.
- 3) If the engine is shut off, it may stall when attempting to restart.

All three events above increase the risk of an accident.

Certified 'GMC' techs will be instructed to inspect the trucks and replace both engine ignition coil pack fuse holder assemblies with new versions.

- An unknown number of 2024 Cadillac XT4s, Chevy Colorado and GMC Canyon pick*ups* that were produced with park lamp function that is not in compliance with Federal Motor Vehicle Safety Standard number 108. The recall describes a remedy available from authorized dealers. When the driver of one of these vehicles switches off the master light control at night or in other dark conditions, the taillights, license plate light, and side marker lamps will switch off. However, the parking lamps will remain on. Federal motor vehicle safety standards require that if the parking lamps are on, the taillights, license plate light, and side marker lamps must also be illuminated. Since this is not the case in affected trucks, they are out of compliance with federal law. Certified 'GMC' techs will reprogram the Body Control Module. No parts are required to fix of this issue.
- A total of 11,542 2025 Cadillac Lyrigs that have an inaccurate description of rear-seat head restraint usage in the owner's manual. The Lyrigs were shipped with owner's manuals that contain incorrect information on how

to adjust the rear outboard head restraint. The instructions as printed show how to adjust the *Chi*nese Lyriq variant's headrest. which does not use the same adjustment method as the *North*

(or the Lyrig any-

American Lyriq where else in the world). Incorrectly adjusting the rear seat head restraints following the instructions included in the noncompliant manual might increase the risk of injury in the event of a crash or collision. The manuals are also not in compliance with US and Canadian regulations about printed safety instructions. A remedy requiring no parts is available. 'GMC' will mail a printed insert to all owners of record with correct head restraint adjustment instructions. which should be inserted in the manual. This insert will also be supplied to dealers and owners can opt to have it inserted at the dealership. Dealers must also add the special insert to the owner's manual of any Lyriq crossovers in their inventory before selling or delivering them. Owners should wait for the arrival of the correct Lyriq headrest adjustment instructions from 'GMC' and insert these in their owner's manual. or have the dealership do this. Inserts will be mailed on May 12th, 2025.



An unknown number of 2023 -25 Cadillac Lyrigs that have loose front stabilizer bar bracket bolts.

'GMC' Safety Recall numbers N252494190 and N252494191 also describe a remedy available to Lyriq owners. 'GMC' issues two separate recalls one for the left front stabilizer bar and another for the right front stabilizer bar.

The vehicles were shipped with improperly fastened front stabilizer bar bracket bolts. If both bolts on the left or right bracket loosen and separate from the frame, a loose stabilizer bar or bracket can damage the vehicle's high-voltage cables or EV battery coolant lines. If these cables or lines are sufficiently damaged, over time, the vehicle may shut off or become undriveable, increasing the risk of an accident

'GMC' service techs will inspect and, as necessary, retorque or replace these bolts. Owners should wait for 'GMC' to communicate whether their Lyriq is affected by the recalls—Assorted sources 🚔
